

## Asia Pacific Group 1<sup>st</sup> Sports Competition – Terms & Conditions

### 1. Definitions

- A. Organization/Organizer/APG means Asia Pacific Group
- B. Eligible Player means a registered player eligible to receive a voucher under APG tournament
- C. Eligibility criteria – means the eligibility criteria that APG must comply with outlined 3
- D. Voucher means issued under the APG program for the winners for a specific value up to 50% discount to migration and 10% in education fees which can be redeemed at a Sydney Branch office of Asia Pacific Group.
- E. Event means Asia Pacific Group Sports Competition
- F. Participant means players or attendees

### 2. Application

- These terms conditions apply to the acceptance and redemption of players joining under Asia Pacific Group sports competition.

### 3. Eligibility criteria

- To be eligible with the offer, intend players must join and registered in APG official website
- Ages 21 to 39 years old

### 4. As a Participant, you agree:

- Voucher cannot be converted into cash
- Attendance requirements during the event
- Additional cost/ and or may shoulder by the attendee in participating in the event e.g travel cost to the location
- You will play fair and practice sportsmanship
- You will have informed the management when bringing colleagues and friends

### 5. As an Organizer, we agree;

- We will commit with our voucher offered
- Give you a quality of service
- Organization will ensure to provide referees, first aid officers and other relevant staff and volunteers are accredited by APG for this event
- Provide Food during the event

### 6. Verification

The organization reserves the right at its discretion to verify any information provided as part of the redemption process of the voucher. Verification may include without limitation any or all the following:

- a. Requesting the provision of additional information
- b. APG reserves the right, at any time, to verify the validity of claims and claimants (including a claimant's identity, age and place of residence) and to disqualify any claimant who submits a claim that is not in accordance with these Terms and Conditions or who tampers with the claim process. Errors and omissions may be accepted at APG discretion. Failure by the APG to enforce any of its rights at any stage does not constitute a waiver of those rights.
